

# St Therese Holy Land Pilgrimage

## Terms and Conditions

**TOTAL TOUR PRICE:** The tour price is based on airfare, land rates and rates of exchange in effect April 10, 2021. All rates are subject to change without prior notice. Should the rates go up or down, an adjustment would be made prior to departure. Refunds CANNOT be granted for any accommodations, services or events that are not used nor if you deviate from the tour. If fewer than 35 pilgrims participate a price adjustment may be necessary.

**PASSPORT AND VISA REQUIREMENTS:** A valid passport is required. At the time of printing, U.S. citizens holding valid passports DO NOT REQUIRE visas or immunization for the country or countries being visited. Passport MUST be valid until August 9, 2022 or later. Citizens of countries other than U.S. - please contact the consulate of the country or countries being visited to determine visa requirements.

**GROUP AIR:** Seat assignments cannot be guaranteed, with seats being assigned at check in. Group air is not upgradeable. Provide frequent flyer numbers at check in to find out airline policy for mileage eligibility. Nobile Travel Tours will not be held responsible for flight cancellations or delays (please consider travel insurance to cover these losses). Once the tickets are issued, they are NON-REFUNDABLE. Additional non-recoverable airline penalties of up to \$200 may be assessed for cancellations received within 90 days of departure.

**DOMESTIC AIRFARE:** For those who make domestic air arrangements to the originating city of this tour, Nobile Travel Tours strongly recommends the purchase of tickets that can be changed without heavy fees and penalties as international flight schedules are always subject to change.

**HOTEL ACCOMMODATIONS:** Specially selected hotels based on double occupancy with private bath. Single Room supplement of \$750 will be charged where requested and available. If you do not have a roommate and Nobile Travel is unable to arrange one, you will be billed for the single room supplement. All singles are subject to availability.

**MEALS:** Breakfast and dinner are provided daily except where noted in the itinerary.

**TIPS AND TAXES:** Tips and taxes normally appearing on hotel and restaurant bills as service are included, as are all government and local taxes on hotels and meals, and portage of one suitcase per person. One average sized suitcase not exceeding 50 lbs total weight and 62 linear inches (height plus width plus depth) is permitted throughout the trip. International departure taxes and current fuel surcharges are included (subject to change).

**NOT INCLUDED:** Expenses and items not specifically mentioned are NOT covered, including but not limited to: passport and visa fees, meals not listed and items of a personal nature such as laundry, wines, liquors, mineral waters, after dinner coffee or tea, sightseeing or services other than those specifically mentioned, tips and taxes mentioned above, excess baggage and insurance, etc. Tips to Tour Manager/Guides, drivers and dining rooms staff are not included.

**DEPOSIT AND PAYMENTS:** A deposit of \$350 is required to secure a reservation. A second payment of \$1,250 is four months before departure with balance to be paid in full 60 days before departure. Final payments received by Nobile Travel Tours after 45 days before departure will incur a \$50 late payment fee. Reservations made within 60 days of departure must include full payment. Amex, Visa and Mastercard, and Discover are accepted with a 3.5% processing fee. Final payments will be applied to same credit card on final payment due date unless Nobile Travel Tours is notified in writing.

**CREDIT CARDS:** Credit card payments are accepted; however, Nobile Travel Tours must pass on a 3.5% fee assessed by the credit processing company. Payments made with check or cash will not incur this fee.

**CANCELLATIONS** Cancellation in writing must be received by Nobile Travel Tours 100 days prior to departure for refund of deposit minus service fee. Air penalties are not part of the percentages below and vary based on the airline policy at the time of ticket issue.

- 100+ Days Prior: \$100 Per Person Service Fee
- 99-61 Days Prior: Deposit Amount
- 60-46 Days Prior: 40% of tour cost
- 45-31 Days Prior: 65% of tour cost
- 30-8 Days Prior: 85% of tour cost
- 7 Days Prior or less: 100% of tour cost

**BANK FEE:** A fee of \$50 will be charged for any check that is returned to us for insufficient or unavailable funds.

**DEVIATIONS:** Not allowed

**TRAVEL INSURANCE:** Optional travel insurance is strongly recommended for your trip. To cover preexisting conditions, insurance must be purchased within 14 days of paid deposit. Contact Nobile Travel for more information.

**LAND ARRANGEMENTS:** The tour operator reserves the right to change the itinerary due to unforeseen circumstances.

**RESPONSIBILITIES:** Nobile Travel Tours, the tour operator, and their representatives act only as agents for the tour members in arranging for hotels, transportation, sightseeing, restaurants, or any other services relating to the itinerary.
